FULL SET OF SERVICES

- Daily monitoring of cash flows (including from external cash accounts)
- Continuous risk assessment and improvement of asset management companies' procedures
- Independent NAV recalculation in compliance with local regulations (e.g. Germany and Italy)
- Regulatory ratio recalculation for portfolios administered externally
- Set-up of reports and other mandatory statements to regulators (AIFM, FATCA, AEOI, EMIR etc)
